Meeting Minutes NORTH TEXAS CORVETTE CLUB October 1, 2021

Vice President, Mike Martin called the October 1st meeting of the North Texas Corvette Club to order at 7:33 pm in the showroom of the James Woods dealership.

The September meeting minutes were read and approved by Linda Cassidy & seconded by Ken Bradshaw.

Cindy Smith, Treasurer, updated the totals in the checking, CD accounts and the 50/50 balance. She also detailed the monthly deposits and expenses. Cindy announced that the CD Accounts would be turned over to cash. Those planning to attend the Christmas Party should plan to pay for the event at the November Club Meeting or by mailing a check to her. Kay Pace noted that she has received only 1 response to the request for members to notify her of the date they joined the NTCC. There was a discussion requesting ideas for how to honor long-standing members of the club, and a reminder that members take a moment to respond to Kay's request.

There was also a discussion about the potential of using group texts as a communication tool for the club. Susan Rayshell offered that group texts should only be used to disseminate information.

Currently only 25 individuals have signed up for the Christmas Party. The club will need a total of 50 individuals (25 couples) to confirm the reservation. The venue is the Hilton Garden Inn at Alliance airport at a cost of \$130/couple with rooms at the hotel available for the membership at \$89. The 50/50 balance will assist with cost of the party.

In New Business, Mike again asked that members consider stepping up for leadership positions and thanked those who have served and are currently serving.

Mike Martin won the 50/50 pot of \$35.

The meeting was adjourned at 8:37 pm. There were 37 in-person & "zoomers" in attendance.
